On December 1, 2022, the Staff of the Commission (Staff) filed a report and recommendation regarding the application in this matter. On December 12, 2022, the Commission granted the request of Union Electric Company d/b/a Ameren Missouri to extend the deadline to file a response to Staff's recommendation to December 19, 2022.

On December 19, 2022, Ameren Missouri filed a *Motion for Further Extension* in which it requested, due to ongoing discussions with Staff, that it be given until January 6, 2023, to file a stipulation, status report, or response to Staff's recommendation on Ameren Missouri's application. Staff does not oppose Ameren Missouri's motion.

The Commission finds Ameren Missouri's motion reasonable and will grant it.
