## ORDER ADOPTING PROCEDURAL SCHEDULE

Issue Date: October 7, 2022

Effective Date: October 7, 2022

On July 15, 2022, the Commission ordered the Staff of the Commission to file a recommendation or status report stating when it expected to file a recommendation no later than August 30, 2022. Staff filed a Status Report and Procedural Recommendation asking the Commission allow it to either file a recommendation as soon as it could, or, file rebuttal testimony no later than December 21, 2022. Staff also suggested a procedural schedule for surrebuttal, hearing dates and briefing. Ameren Missouri filed a response on September 9, 2022, objecting to certain dates set out by Staff. On September 19, 2022, the parties filed a jointly agreed to proposed procedural schedule. The parties also included certain procedures for the timing of data requests and objections to data requests.

The Commission has reviewed the proposed procedural schedule and procedures, finds them reasonable, and will adopt them. In addition, the Commission will add various procedural filings and requirements to the schedule.

### THE COMMISSION ORDERS THAT:

1. The following procedural schedule is established:

2. The hearing shall be held at the Commission’s office at the Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act. If you need additional accommodations to participate in this hearing, please call the Public Service Commission’s Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

3. The parties shall comply with the following procedural requirements:
- (A) For written testimony, all parties must comply with the requirements of Commission Rule 20 CSR 4240-2.130 for prepared testimony, including the requirement that testimony be filed on line-numbered pages.
  - (B) For any data requests propounded on or after December 21, 2022, responses to data requests shall be made within five calendar days and objections or notice of need for more time respond to data requests shall be made with two business days.
  - (C) Although not all parties may agree upon how each issue should be described or on whether a listed issue is in fact a proper issue in this case, the parties shall agree upon and file a list of the issues to be heard, the witnesses to appear on each day of the hearing, the order in which they will be called, and the order of cross-examination for each witness. The Commission will view any issue not contained in this list of issues as not requiring resolution by the Commission.
  - (D) Each party shall file a simple and concise statement summarizing its position on each disputed issue. Position statements shall track the list of issues. Any position statement shall set forth any order requested, cite any

law authorizing that relief, and allege facts relevant under the law with citations to any prefiled testimony in support.

- (E) All pleadings, briefs, and amendments shall be filed in accordance with Commission Rule 20 CSR 4240-2.080. Briefs shall follow the same list of issues as filed in the case and must set forth and cite the proper portions of the record concerning the remaining unresolved issues that are to be decided by the Commission.
- (F) If part of the testimony or documents are prefiled and served upon the parties before a hearing, a party need only provide a copy of the testimony or document to the court reporter to be marked as an exhibit at the hearing. If not prefiled and served upon the parties, then a party who has a document marked for use at the hearing shall have sufficient copies of the document to provide a copy not only to the court reporter, but also to each Commissioner, the presiding officer, and counsel for each other party.
- (G) Exhibit numbers are assigned in the following manner:

Ameren Missouri	1-99
Commission Staff	100-199
Office of the Public Counsel	200-299

- (I) Each party shall prepare a list of its pre-filed, pre-marked exhibits and file a copy of that list in the EFIS file. Exhibits that may be offered during cross-examination, but which have not been pre-filed, need not be included on the list. However, when those documents are offered during the hearing, they will be assigned a number from that party's number group.
4. This order is effective when issued.
