**ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFFS**

Issue Date: June 18, 2008

Effective Date: July 1, 2008

On May 14, 2008, Time Warner Telecom of Kansas City LLC filed notification of its change of corporate name to "tw telecom of kansas city llc" and four new tariffs reflecting the name change. The tariffs bear an effective date of July 1, 2008. The Company filed substitute tariff sheets for Tariff No. JC-2008-0675 on June 13, 2008.

The Staff of the Missouri Public Service Commission filed a verified recommendation on June 17, 2008. Staff recommends that the Commission recognize the new name. Staff states that the company's application clearly sets out the old name and new name, includes evidence of registration of the name change with the Missouri Secretary of State, and includes four new tariffs with the new name.

The Commission has reviewed the application and Staff's recommendation, which are hereby admitted into evidence. The Commission finds that Time Warner Telecom of Kansas City, LLC's name change to tw telecom of kansas city llc shall be recognized and the proposed tariffs shall be approved.

**IT IS ORDERED THAT:**

1. The Commission recognizes the name change of Time Warner Telecom of Kansas City, LLC, to tw telecom of kansas city llc.


