**ORDER APPROVING TARIFF**

Issue Date: May 26, 2023

Effective Date: June 5, 2023

On December 12, 2022, Missouri-American Water Company (Missouri-American) filed the above-referenced application. The Commission approved the application on May 18, 2023. In the order approving the application, the Commission ordered Missouri-American to file a tariff.

Missouri-American filed a tariff on May 19, 2023. That tariff bears an effective date of June 18, 2023. However, Missouri-American asks for expedited treatment so that the tariff may become effective on June 1, 2023, or as soon thereafter as is practicable.

The Commission’s Staff filed both a Recommendation and an Amended Recommendation on May 24, 2023. The Amended Recommendation stated that the Commission should approve the tariffs on the expedited basis MAWC requests.

Section 393.140(11) allows the Commission to approve a tariff on less than thirty days’ notice upon good cause. Based on Missouri-American’s assertion that the City of O’Fallon needs to supplement its water supply to address anticipated demand, the Amended Recommendation of Staff, and the lack of objection from any party, the Commission finds good cause to approve the tariff on an expedited basis.

**THE COMMISSION ORDERS THAT:**

1. The Motion for Expedited Treatment is granted.
2. The tariff filed by Missouri-American Water Company on May 19, 2023, and assigned Tracking No. YW-2023-0205, is approved to become effective on June 5, 2023.
3. This order shall be effective June 5, 2023.
