ORDER SUSPENDING TARIFF, **DIRECTING NOTICE, SETTING INTERVENTION DEADLINE** AND DIRECTING STAFF TO FILE A RECOMMENDATION

On August 30, 2013, Missouri-American Water Company filed a petition to change its Infrastructure System Replacement Surcharge (ISRS). With its petition, the company filed a proposed, revised tariff sheet. The tariff sheet has an effective date of September 29, 2013. The Commission is required to act on this application within 120 days¹, or December 28, 2013. In order to consider this application and allow any party an opportunity to have meaningful input, the Commission must suspend the effective date of this proposed tariff sheet.

The Commission is also required to publish notice of this application. The Commission will therefore notify the general public and others who may be interested, and will set an intervention deadline for any requests to intervene.

Finally, the Commission will direct that the Staff of the Commission file a recommendation.

THE COMMISSION ORDERS THAT:

- 1. The proposed tariff sheet, Tariff Tracking No. YW-2014-0109; specifically, "P.S.C. MO No 13, 3rd Revised Sheet No. RT 10, Canceling 2nd Revised Sheet No. RT 10," is suspended until December 28, 2013.
- 2. The Data Center of the Missouri Public Service Commission shall serve notice of this order upon the County Commission of St. Louis County.
- The Information Officer of the Missouri Public Service Commission shall notify the media serving St. Louis County and the General Assembly representing St. Louis County.
- 4. Applications to intervene shall be filed no later than October 7, 2013. Such applications shall be filed with:

5. The Staff of the Commission shall file a recommendation no later than October 29, 2103.
