**ORDER APPROVING TARIFF**

Issue Date: April 1, 2008

Effective Date: April 6, 2008

On January 28, 2008, ExOp of Missouri, Inc., d/b/a Unite (ExOp), filed an application with the Missouri Public Service Commission seeking approval to adopt the “doing business as” name FairPoint Communications and to operate under that name in Missouri.

On February 19, 2008, the Commission issued an order recognizing the “adoption by ExOp of Missouri, Inc., d/b/a Unite of the fictitious name ExOp of Missouri, Inc., d/b/a FairPoint Communications,” and approving the Adoption Notice and Tariff Sheet for each of two tariffs, PSC MO. No. 1 and PSC MO. No. 3. FairPoint Communications inadvertently failed to submit an adoption notice and title sheet regarding ExOp of Missouri, Inc.’s PSC MO. No. 4 tariff.

On March 7, 2008, FairPoint Communications submitted, among other things, an Adoption Notice and Title Sheet bearing an effective date of April 6, 2008, to reflect its name change in ExOp of Missouri, Inc.’s PSC Mo. No. 4 tariff. At the request of the Commission’s Staff, a corrected Title Sheet was subsequently filed on March 18, 2008.

Staff filed a verified recommendation on March 26, 2008. In its recommendation, Staff stated that it has reviewed FairPoint Communications' proposed tariff and recommends approval of the tariff sheets, as substituted, to effectuate the name change recognized by the Commission in its February 19, 2008 order.

The Commission has reviewed FairPoint Communication's tariff filing and Staff's recommendation, which are hereby admitted into evidence, and finds that the tariffs should be approved.

**IT IS ORDERED THAT:**

1. The tariff filed by ExOp of Missouri, Inc. d/b/a FairPoint Communications, on March 7, 2008, Tariff No. JI-2008-0549, is approved for service on and after April 6, 2008.
