ORDER ACKNOWLEDGING NAME CHANGE AND APPROVING TARIFF

On May 9, 2006, Logix Communications, L.P. (Logix), formerly Western

Communications, Inc., filed a letter requesting that the Commission acknowledge its new

corporate name. The corporate entity, Logix, does business under the fictitious name

"Logix Communications" and was granted authority to do so in Case No. LA-2003-0027. Its

use of that fictitious name is not changing as a result of this case.

As the name the company uses when doing business in Missouri has not

changed, customers have no need to be notified of the name change in compliance with 4

CSR 240-3.545(20), as the name change in this case is not one "affecting customer

recognition of the company." On May 23, 2006, Logix submitted adoption notices and

revised tariff title sheets with an effective date of June 22, 2006.

The Staff of the Missouri Public Service Commission filed a recommendation on

May 24, 2006, stating that it had reviewed the company's tariff pages and recommending

that the Commission acknowledge the name change, note that the company will continue

to use the same fictitious name, Logix Communications, and approve the new tariff pages

filed in conjunction with this case.

The Commission has reviewed Logix's tariff sheets and Staff's verified

recommendation, which are hereby admitted into evidence. Based upon its review, the

Commission finds that the name change should be acknowledged, the continued use of the fictitious name "Logix Communications" should be noted and the tariff sheets should be approved.

IT IS ORDERED THAT:

- Western Communications, Inc.'s name change to Logix Communications,
 L.P. and its continued use of the fictitious name "Logix Communications" are acknowledged.
- 2. The following proposed tariff pages filed by Logix Communications, L.P. on May 23, 2006, Tariff File Nos. YL-2006-0871 and YL-2006-0872 are approved for service on and after June 22, 2006.
