ORDER APPROVING COMPLIANCE TARIFF

Issue Date: August 30, 2021

Effective Date: September 22, 2021

On August 4, 2021,¹ The Commission issued its Report and Order Approving Territorial Agreement. The Report and Order required Evergy Missouri West, Inc., d/b/a Evergy West (Evergy) to file compliance tariff sheets describing the modification of its service territory which include a metes and bounds legal description of the affected parcels no later than October 3. On August 18, Evergy filed a compliance tariff revision, tracking number YE-2022-0038, pursuant to the Commission's Report and Order with an effective date of September 3. On August 23, Evergy filed a compliance tariff revision, tracking number YE-2022-0039, with an effective date of September 22, and on August 24, Evergy filed a Notice of Tariff Withdrawal withdrawing Tariff Revision YE-2022-0038.

On August 24, the Commission issued an Order Directing Filing requiring the Commission Staff's (Staff) recommendation and all comments or objections from other parties to be filed no later than noon on August 30. On August 27, the Staff filed its Recommendation to Approve Evergy's substitute tariff sheets, tracking number YE-2022-0039, with an effective date of September 22.

Staff recommended approval of the compliance tariff sheets. The Commission has reviewed the YE-2022-0039 tariff sheets and finds they are consistent with Staff's recommendation. No other parties have filed comments or objections. The Commission will approve the YE-2022-0039 compliance tariff sheets, to go into effect on September 22. Because the tariff's effective date is September 22, the Commission will make this order effective in less than 30 days.

THE COMMISSION ORDERS THAT:

1. The compliance tariff assigned tracking number YE-2022-0039 is approved to go into effect on September 22, 2021.
