ORDER CANCELING CERTIFICATE AND TARIFF

On January 23, 2018, the Commission issued an order approving the joint application of Jefferson County Public Sewer District (“District”) and Utility Management of Missouri, LLC (“UMM”), as the court-appointed receiver of P.C.B., Inc., seeking authority for the District to purchase substantially all of the sewer assets of P.C.B., Inc. As part of its order, the Commission directed P.C.B., Inc. to file a notice indicating when the closing on the transfer of assets was complete. The District and UMM filed notice on March 2, 2018, indicating that the transfer was completed on February 28, 2018. Because of the transfer, P.C.B., Inc. is no longer providing sewer service in its certificated service territory. As provided in the order issued on January 23, 2018, the Commission will now cancel P.C.B., Inc.’s certificate of convenience and necessity to provide sewer service and its associated tariff.

THE COMMISSION ORDERS THAT:

1. P.C.B., Inc.’s Certificate of Convenience and Necessity to provide sewer service is canceled.

2. P. C.B., Inc.'s sewer service tariff, P.S.C. MO No. 3, Original Sheets No. 1-32, Tariff Tracking No. YS-2014-0411, is canceled.
3. This order shall be effective when issued.
