Dear Judge Woodruff:

The majority of Liberty's general rate case compliance tariff sheets, designed to implement Liberty's authorized annual revenue requirement increase of \$35,515,913, have been approved in Case No. ER-2021-0312, to take effect June 1, 2022.

Certain transportation electrification tariff sheets were part of Liberty's original rate case compliance tariff submission, and on May 12, 2022, Liberty submitted additional transportation electrification tariff sheets. Since the submission of the additional transportation electrification tariff sheets, Liberty continued to work with the Staff of the Commission and the other parties, and it was determined that certain substitute sheets would need to be filed. In this regard, Liberty is filing substitutes for the following tariff sheets:

On May 2, 2022, and to comply with the Commission's *Order Approving Stipulations and Agreements* issued March 9, 2022, effective March 19, 2022, and the Commission's *Report and Order* issued April 6, 2022, effective April 16, 2022, in Liberty's general rate case (ER-2021-0312), Liberty submitted tariff sheets consisting of revised and original rate schedules. The general rate case compliance tariff sheets, designed to implement Liberty's authorized annual revenue requirement increase of \$35,515,913, bear an effective date of June 1, 2022 (30 days after submission). Substitutes for certain tariff sheets were submitted on May 12 and 13, 2022, and Liberty voluntarily extended the effective date of the transportation electrification tariff sheets contained within the rate case compliance package to October 15, 2022.

It should be noted that Liberty's Unopposed Motion to Modify Stipulation and Order and Motion for Expedited Treatment remains pending in Case No. ET-2020-0390. That Motion seeks modification of the Stipulation and the Commission's order approving the same in Liberty's transportation electrification docket to the extent necessary to align with the general rate case compliance tariff sheets. For ease of reference, all of the transportation electrification tariff sheets are being filed in both the general rate case docket and the transportation electrification docket.
