**ORDER APPROVING FUEL ADJUSTMENT TRUE-UP AND APPROVING
TARIFF TO CHANGE FUEL ADJUSTMENT CLAUSE RATES**

Effective Date: May 24, 2017

In each of these files, Union Electric Company d/b/a Ameren Missouri (“the company”) filed a tariff,¹ which it later substituted² (“tariff”), and supporting testimony.³ Staff filed a recommendation in favor of the tariff,⁴ which it revised to address the substitute tariff.⁵ The Commission received no application for intervention.

In File No. ER-2017-0244, the company seeks the Commission's approval of true-up amounts related to the company's fuel adjustment clause ("FAC").⁶ Specifically, the amounts relate to the company's Recovery Period 21 (June 2016 through January 2017). For that period, the company alleges a true-up amount of \$526,405 in over-recovery and \$489,986 in accrued interest. Those amounts are components of the FAC for Accumulation Period 24, which is the subject of File No. ER-2017-0243. In that case, the company asks to adjust the company's rates per kilowatt hour ("kWh") by \$0.00052. For a residential customer using 1,015 kWh per month, the tariff decreases the FAC by approximately \$0.56 to \$0.70 per month.

On the basis of the verified and uncontested filings, the Commission concludes that the tariff conforms to the applicable statutes, regulations, and tariffs, so the Commission will approve the tariff.

THE COMMISSION ORDERS THAT:

1. The tariff assigned Tracking No. YE-2017-0181 is approved to become effective on May 24, 2017.

2. The specific tariff sheet approved is:

3. This order shall be effective on May 24, 2017.
