**ORDER CANCELING CERTIFICATES**

Issue Date: November 14, 2005

Effective Date: November 24, 2005

On June 30, 2005, Acceris Management and Acquisition LLC (Acceris) and Acceris Communications Corp. (ACC) filed a joint application seeking approval of a transaction whereby Acceris would obtain certain Missouri assets of ACC, including the subscriber base of ACC. The Commission subsequently approved the sale of assets, but directed the parties to notify the Commission when the authorized transactions were complete so that the Commission could cancel the certificate of service authority and tariffs of ACC. On October 25, 2005, the Applicants notified the Commission that the transactions had been completed. Applicants also requested that the Commission cancel the certificates of service authority and tariff of ACC, and that the Commission cancel any remaining tariffs of Worldxchange Corp. or Worldxchange Corp., d/b/a Acceris Communications.

On November 2, 2005, the Commission's Staff filed its Cancellation Recommendation. Staff notes that ACC was granted a certificate of service authority on July 31, 2000, in Case No. TA-2000-847, as PPT-1 Counsel, Inc.; the company, however,

has since changed its name three times. Staff recommends that the Commission cancel the certificate of service authority to provide interexchange telecommunications service that was initially granted to the predecessor of ACC, as well as its tariff, MISSOURI P.S.C. NO. 2. Staff also states that it seeks cancellation of Worldxchange Corp.'s MISSOURI P.S.C. NO. 1 and Worldxchange Corp. d/b/a Acceris Communications' P.S.C.MO. TARIFF NO. 3, neither of which were canceled over the course of the name changes leading up to the certification of ACC. On November 9, 2005, Acceris filed a response, indicating that it supports Staff's Cancellation Recommendation.

Under Section 392.410, RSMo Supp. 2004, the Commission has the authority to cancel a telecommunications corporation's certificate. After reviewing Staff's recommendation and the company's response, the Commission determines that it is appropriate to cancel the certificate of service authority to provide interexchange telecommunications service that was initially granted to the predecessor of ACC on July 31, 2000, in Case No. TA-2000-847, as well as its tariff, MISSOURI P.S.C. NO. 2. The Commission will also cancel Worldxchange Corp.'s MISSOURI P.S.C. NO. 1 and Worldxchange Corp. d/b/a Acceris Communications' P.S.C.MO. TARIFF NO. 3.

**IT IS THEREFORE ORDERED:**

1. That the certificate of service authority granted to Acceris Communications Corp.'s predecessor, PT-1 Counsel, in Case No. TA-2000-847, and the accompanying tariff, MISSOURI P.S.C. NO. 2 (Tariff No. YX-2005-0154), are canceled.

2. That the tariff of Worldxchange Corp, MISSOURI P.S.C. No. 1 (Tariff No. JX-2003-0319), and the tariff of Worldxchange Corp d/b/a Acceris Communications, P.S.C. MO TARIFF NO. 3 (Tariff No. YX-2003-1865), are canceled.

3. That this order shall become effective on November 24, 2005.
