ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: March 4, 2008 Effective Date: March 14, 2008

On February 4, 2008, Syniverse Networks, Inc., filed a pleading surrendering its certificate of service authority. Syniverse stated that it has no customers in Missouri and, therefore, surrender of its certificate is not detrimental to the public interest.

Syniverse was formerly known as TSI Telecommunications Network Services, Inc., under which name it was granted authority to provide interexchange and nonswitched local exchange telecommunications services on November 13, 2003, in Case No. XA-2004-0187. On June 17, 2004, in Case No. XN-2004-0593, the Commission acknowledged TSI Telecommunications' change of corporate name to Syniverse Network Services, Inc., and approved its tariff reflecting the new name, assigned Tariff File No. YX-2004-1406 in the Commission's Electronic Filing and Information System.

The Staff of the Commission filed a recommendation and memorandum on February 29, 2008. Staff has no objection to Syniverse's request for cancellation and recommends that the Commission cancel the certificate of service authority, as well as Syniverse's tariff, P.S.C. Mo. No. 1.

The Commission has considered Syniverse's pleading and Staff's recommendation. Inasmuch as the Company has no customers in Missouri and Staff recommends cancellation of the certificate and tariff, the Commission finds that it is reasonable and not detrimental to the public interest to accept Syniverse's surrender of its certificate. Syniverse's certificate of service authority and tariff shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of service authority to provide interexchange and nonswitched local exchange telecommunications services granted to Syniverse Network Services, Inc., under its former name of TSI Telecommunications Network Services, Inc., in Case No. XA-2004-0187, is canceled.
- 2. Syniverse Network Services, Inc.'s tariff P.S.C. Mo. No. 1, Tariff File No. YX-2004-1406, is canceled.
 - 3. This order shall become effective on March 14, 2008.
 - 4. This case may be closed on March 15, 2008.
