**ORDER APPROVING TARIFFS**

Issue Date: October 22, 2015

Effective Date: November 1, 2015

Branson Cedars Resort Utility Company LLC (“applicant”) filed the pending tariffs<sup>1</sup> pursuant to the Commission’s *Order Granting Certificates of Convenience and Necessity with Conditions*<sup>2</sup> (“order”), which required applicant to file tariffs in compliance with that order’s description. The pending tariffs bear a proposed effective date of November 1, 2015.

The Commission may approve any tariff without a hearing or any other procedure,<sup>3</sup> so this action is not a contested case,<sup>4</sup> and the Commission need not separately state its findings of fact.

Staff filed a recommendation in favor of approving the tariffs.<sup>5</sup> No other party filed a response to the tariffs within the time set by order for such filing.<sup>6</sup> The absence of

opposition to the tariffs supports an effective date less than 30 days from issuance of this order.<sup>7</sup> Therefore, the Commission independently concludes that the tariffs support safe and adequate service at just and reasonable rates,<sup>8</sup> and will approve the tariffs to become effective on November 1, 2015.

**THE COMMISSION ORDERS THAT:**

1. The tariff to which the Commission assigned tracking no. YW-2016-0096 is approved. The specific tariff sheets approved are:
