**PUBLIC COUNSEL’S MOTION FOR APPOINTMENT OF A MEDIATOR**

COMES NOW the Office of the Public Counsel and for its Motion for Appointment of a Mediator states as follows:

1. On August 31, 2011, Jimmie E. Small filed a complaint against Union Electric Company d/b/a Ameren Missouri UE.<sup>1</sup>
2. On October 26, the Commission issued an order directing the parties to state “what remedy, if any, the Commission has authority to grant Mr. Small in the event he prevails in his complaint.” Several responses were filed on November 7; Public Counsel’ response suggested that there may be a dispute within the jurisdiction of the Commission, and that the dispute may be resolved in such a manner as to provide relief to the Complainant.
3. On November 3, Mr. Small filed a request for mediation.<sup>2</sup> It appears that mediation would be very helpful in this case, but Ameren has neither accepted nor rejected Mr.

<sup>2</sup> The filing is titled in EFIS as “Complainant’s Letter to Ameren Missouri,” but it is clearly a request for mediation. The concluding sentence reads: “The undersigned respectfully request Respondent Utility respond to Company’s desire for MEDIATION in Case No 2012-0050, and as to any specific point of interest subject to mediation.”

Small's request for mediation. Public Counsel suggests that the Commission appoint a mediator pursuant to 4 CSR 240-2.125(2)(A) and (B).

WHEREFORE Public Counsel respectfully requests that the Commission appoint a mediator pursuant to 4 CSR 240-2.125(2)(A) and (B).
