ORDER AND NOTICE

On December 30, 2021, Liberty Utilities (Midstates Natural Gas) Corp. d/b/a Liberty filed an application pursuant to Sections 393.1009, 393.1012, and 393.1015, RSMo. 2016, and Commission Rules 4 CSR 240-2.060, 2.080, and 3.265. The application requests that the Commission authorize changes to Liberty's Infrastructure System Replacement Surcharge (ISRS). Liberty also filed tariff sheets which bear an effective date of April 1, 2022.

Section 393.1015.2(3), RSMo, requires that the Commission act on the application no later than 180 days after it is filed. In order for the Commission to have adequate time to consider Liberty's application, the proposed revised tariff sheets will be suspended for those 180 days, which is until June 28, 2022.

Additionally, Section 393.1015.1(2), RSMo, requires that the Commission publish notice of the filings. Therefore, the Commission will give notice of this application to the general public and any interested persons and set other procedural deadlines.

Section 393.1015.2(2), RSMo, allows the Commission's Staff to examine Liberty's application and allows Staff to submit a report of its examination no later than 90

days after the application was filed. Consequently, the Commission will establish a deadline for Staff to file its recommendations. The Commission will also set a time for responses to those filings.

THE COMMISSION ORDERS THAT:

1. The tariff sheets filed by Liberty and assigned tariff numbers YG-2022-0194 are suspended until June 28, 2022.
2. The Commission's Data Center shall provide notice of this proceeding to the county commission of all of the counties within Liberty's service areas.
3. The Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving Liberty's service areas and to the members of the General Assembly representing those service areas.
4. The Data Center shall also provide a copy of this notice to the parties in Liberty's last general rate case, File No. GR-2018-0013.
5. Any entity wishing to intervene shall file an application to do so no later than January 18, 2022.
6. Any responses to the applications to intervene shall be filed no later than January 23, 2020.
7. The Staff of the Commission shall file its report no later than March 30, 2022.
8. Any responses to the Staff report shall be filed no later than April 7, 2022.

9. This order shall become effective when issued.


