# ORDER APPROVING TARIFF AND GRANTING MOTION FOR EXPEDITED TREATMENT

On August 31, 2022, the Commission issued its order granting Missouri-American Water Company (MAWC) a certificate of convenience and necessity (CCN) to acquire and operate a water and sewer system in and around the city of Purcell, in Jasper County, Missouri. The Commission's order directed MAWC to file tariff sheets conforming to the Commission's order prior to closing on the assets. On October 2, 2022, MAWC filed tariff sheets to comply with the Commission's order along with a motion for expedited treatment. MAWC's compliance tariff sheets bear an effective date of November 1, 2022, but MAWC's motion for expedited treatment asks the Commission to approve the compliance tariff sheets to take effect on October 25, 2022, prior to closing of the purchase of assets for the City of Purcell.

The Commission directed its Staff (Staff) to file a recommendation about the compliance tariff sheets, and set a deadline for any responses to MAWC's compliance

tariff sheets. Staff filed a statement advising that the tariff sheets comply with the Commission's order. No other responses were received.

The Commission has reviewed the compliance tariff sheets and Staff's recommendation and finds that the tariff sheets should be approved. The Commission has also reviewed the motion for expedited treatment and finds that good cause exists under Section 393.140(11), RSMo, to expedite the effective date of the tariff sheets to conform to MAWC's expected closing on assets. The Commission will approve MAWC's compliance tariff sheets to become effective on October 25, 2022. In addition, the Commission finds it reasonable under Section 386.490.2, RSMo, to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff sheets.

# THE COMMISSION ORDERS THAT:

1. MAWC's motion for expedited treatment is granted.

2. The following tariff sheets filed by MAWC and assigned Tracking Nos. YW-2023-0061 and YS-2023-0062, are approved to become effective on October 25, 2022:
