Re: Tariff Filing to Establish an Infrastructure System Replacement Surcharge

Dear Secretary:

Enclosed for filing is <u>P.S.C. MO. No. 6</u>, <u>First Revised Sheet No. 10</u>, which is applicable to the MGE operating unit of Laclede Gas Company ("MGE").

This revised tariff sheet, which has an issue date of July 25, 2014 and an effective date of August 25, 2014, is being filed to establish an Infrastructure System Replacement Surcharge ("ISRS") in accordance with Sections 393.1009, 393.1012 and 393.1015 of the Revised Statutes of Missouri. A full explanation of the surcharge being proposed by the Company is set forth in the *Verified Application and Petition of MGE to Establish an Infrastructure System Replacement Surcharge*, which is being filed separately today. As proposed herein, the ISRS would increase the typical residential heating customer's bill by 42 cents per month or approximately 0.5%.

Please bring this filing to the attention of the appropriate Commission personnel.

INFRASTRUCTURE REPLACEMENT SURCHARGE (ISRS)

<u>Description</u>: Rate ISRS is designed to recover the costs associated with the Company's eligible infrastructure replacements in accordance with the provisions of sections 393.1009, 393.1012 and 393.1015, RSMo.

<u>Applicability</u>: Rate ISRS is applicable to each customer billing for service during the effectiveness of the ISRS rate element.

ISRS Rate Element: In addition to the other charges provided for in the Company's tariff, a monthly ISRS Rate Element shall be added to each bill for service on and after the effective date of the ISRS rate. The amount of the ISRS Rate Element, by customer class, is as follows:

Residential	\$0.42 per month	*
Small General Service	\$0.61 per month	*
Large General Service	\$1.72 per month	*
Large Volume Service	\$13.51 per month	*
Whiteman Air Force Base	\$13.51 per month	*
Intrastate Transportation Service	\$13.51 per month	*

* - indicates new rate
