**ORDER GRANTING MOTION FOR EXPEDITED TREATMENT AND
APPROVING TARIFFS IN COMPLIANCE WITH COMMISSION ORDER**

Effective Date: November 18, 2013

On October 30, 2013, the Commission issued an order approving a Stipulation and Agreement between KCP&L Greater Missouri Operations Company (“GMO”), Office of the Public Counsel, Brightergy, LLC, Missouri Division of Energy, Missouri Solar Energy Industries Association, and the Staff of the Commission. Consistent with the terms of the Stipulation and Agreement and the Commission’s order, GMO withdrew its previously submitted Net Metering Interconnection and Solar Photovoltaic Rebate Program tariff sheets and filed new tariff sheets that reflected the changes agreed to by the parties. On November 8, 2013, the same day GMO withdrew its original tariff sheets (Tariff Tracking No. JE-2014-0059) it also submitted new tariff sheets, with a December 8, 2013 effective date, to comply with the Commission’s order.

In addition to seeking approval of the new tariff sheets (Tariff Tracking No. YE-2014-0214), GMO filed a motion requesting expedited treatment, so the tariff sheets could go into effect on November 18, 2013. That same day, the Commission issued an order directing Staff to file a recommendation no later than the 13th of November. The Commission also gave all other interested parties until November 14th to file a response. Under the terms of the Stipulation and Agreement, all parties agreed to not oppose GMO’s request for

expedited approval of new tariff sheets, if compliant with the terms of the Stipulation and Agreement. Staff filed a recommendation that the tariff sheets be approved and the motion for expedited treatment be granted. No other parties filed a response.

Upon review of the pleadings, the Commission finds that GMO's tariff sheets comply with the Commission's October 30, 2013 order, and will therefore approve them. Furthermore, the Commission finds that good cause exists for the tariffs to become effective in less than thirty days. For this reason, the Commission will approve the tariffs becoming effective on November 18, 2013.

THE COMMISSION ORDERS THAT:

1. The following tariff filed on November 9, 2013 by KCP&L Greater Missouri Operations Company, and assigned Tariff Tracking No. YE-2014-0214, is approved to become effective on November 18, 2013:
