Here is a follow-up on our meeting today:

#### Belleview Options

- A - Underground feed from switchgear to new terminal pole at Clarkson, clean-up overhead from 25<sup>th</sup> Street to 26<sup>th</sup> Street, eliminate old terminal pole (\$35,000 KCPL, \$3,100 Westhues)
- B - Clean-up existing terminal pole and all other overhead lines and poles
- C - All underground feed from existing manhole to 26<sup>th</sup> Street and 25<sup>th</sup> Street, overhead feed to new transformer pole at Clarkson, underground secondaries (1), overhead secondaries (2) (\$135,000 KCPL, \$45,000 Westhues)

#### 26<sup>th</sup> Street Options

- A - Move all overhead lines to south side of street; re-feed Output Technologies underground at SW Blvd (already have this price) (\$75,000 KCPL, \$0 Westhues)
- B - Move only portion of overhead from alley to SW Blvd to south side of street; re-feed Output Technologies underground (\$40,000 KCPL, \$0 Westhues)

Please let me know if I've missed anything. We will have an answer back to KCPL by June 24<sup>th</sup>, 2005.
