Enclosed for filing with the Missouri Public Service Commission (Commission) on behalf of Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers), please find in electronic format certain water and sewer tariff sheets (list attached).

These tariff sheets are being filed to adopt the existing water and sewer tariffs of Elm Hills Utility Operating Company, Inc. (Elm Hills) pursuant to the Commission's *Order Approving Merger* issued in Case No. WM-2021-0412.
