ORDER CANCELING CERTIFICATE
AND ACCOMPANYING TARIFF

Issue Date: July 12, 2006

Effective Date: July 22, 2006

On June 13, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of W2COM International, LLC, a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number XA-2000-379, the Commission granted W2COM a certificate to provide intrastate interexchange telecommunications services. W2COM's tariff, PSC Mo. Tariff No. 1, was also approved.

Staff's motion states that on April 13, 2006, W2COM filed Articles of Cancellation of a Foreign Limited Liability Company with the Missouri Secretary of State's Office. The company indicated in that filing, "[t]he limited liability company is not transacting business and surrenders its authority to transact business in the State of Missouri." The company's authority was canceled on April 13, 2006.

Staff attempted to contact W2COM via U.S. Mail and telephone without success. Staff served copies of their Motion upon the company at the address on file with the Commission and upon the Missouri Secretary of State, as the Articles of Cancellation revoked the authority of the company's registered agent to accept service of process and indicated that service is to be made on the Secretary of State of Missouri instead.

The company failed to file a 2005 Annual Report to the Commission. W2COM owes no assessments to the Commission. No complaints have been filed against the company since the commencement of the Electronic Filing and Information System. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, PSC Mo. Tariff No. 1, to provide intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, W2COM's lack of authority to transact business in Missouri, because the company does not provide telecommunication service in Missouri and has ceased to exist, the Commission finds that the certificate of service authority and accompanying tariff granted to W2COM International, LLC, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to W2COM International, LLC, in Case Number XA-2000-379, is canceled.
2. W2COM International's tariff, PSC Mo. Tariff No. 1, is canceled.
3. This order shall become effective on July 22, 2006.
4. This case may be closed on July 23, 2006.
