## **ORDER CANCELING CERTIFICATES AND ACCOMPANYING TARIFFS**

Issue Date: July 25, 2006

Effective Date: August 5, 2006

On June 29, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificates of service authority and accompanying tariffs of OCMC, Inc., doing business under four fictitious names, which has been authorized to offer intrastate interexchange and non-switched local exchange telecommunications services by the Commission.

In Case Number TA-2003-0054, the Commission granted OCMC, Inc. d/b/a AdvantTel a certificate to provide intrastate interexchange and non-switched local exchange telecommunications services. The company's tariff, PSC Mo. Tariff No. 1, was also approved.

In Case Number TA-2003-0055, the Commission granted OCMC, Inc. d/b/a 1-800-MAX-SAVE a certificate to provide intrastate interexchange and non-switched local exchange telecommunications services. The company's tariff, PSC Mo. Tariff No. 1, was also approved.

In Case Number TA-2003-0057, the Commission granted OCMC, Inc. d/b/a One Call Communications, Inc., a certificate to provide intrastate interexchange and non-switched local exchange telecommunications services. The company's tariff, PSC Mo. Tariff No. 1, was also approved.

In Case Number TA-2003-0058, the Commission granted OCMC, Inc. d/b/a Opticom a certificate to provide intrastate interexchange and non-switched local exchange telecommunications services. The company's tariff, PSC Mo. Tariff No. 1, was also approved.

Staff's motion states the president of The Meridian Group informed Staff via a letter that the United States District Court for the Southern District of Indiana has appointed Meridian Financial Advisors, Ltd. d/b/a The Meridian Group as the Receiver over the assets of OCMC, Inc., and all four fictitious names certificated in Missouri. In addition, OCMC, Inc. has "relinquish(e)d any and all certificates, licenses, or other indicia of regulatory authorization."

OCMC, Inc. is in good standing in Missouri, according to the Missouri Secretary of State's Office. Staff served copies of its motion upon the company at the address on file with the Commission via certified mail, as well as the company's registered agent.

OCMC owes no assessments under any fictitious name to the Commission. In addition, any informal complaints or inquiries received regarding the company have been closed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or

service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Because OCMC, Inc. has requested cancellation of its certificates, it no longer has authority to transact business in Missouri, and because the company does not provide telecommunication services in Missouri, the Commission finds that the certificates of service authority and accompanying tariffs granted to each of OCMC, Inc.’s certificated fictitious names shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide intrastate interexchange and non-switched local exchange telecommunications services granted to OCMC, Inc. d/b/a AdvantTel, in Case Number TA-2003-0054, is canceled.
2. AdvantTel’s tariff, PSC Mo. Tariff No. 1, is canceled.
3. The certificate of authority to provide intrastate interexchange and non-switched local exchange telecommunications services granted to OCMC, Inc. d/b/a 1-800-MAX-SAVE, in Case Number TA-2003-0055, is canceled.
4. 1-800-MAX-SAVE’s tariff, PSC Mo. Tariff No. 1, is canceled.
5. The certificate of authority to provide intrastate interexchange and non-switched local exchange telecommunications services granted to OCMC, Inc. d/b/a One Call Communications, in Case Number TA-2003-0057, is canceled.
6. One Call Communications’s tariff, PSC Mo. Tariff No. 1, is canceled.

7. The certificate of authority to provide intrastate interexchange and non-switched local exchange telecommunications services granted to OCMC, Inc. d/b/a Opticom, in Case Number TA-2003-0058, is canceled.

8. OCMC, Inc. d/b/a Opticom's tariff, PSC Mo. Tariff No. 1, is canceled.

9. This order shall become effective on August 5, 2006.

10. This case may be closed on August 6, 2006.
