ORDER CANCELING CERTIFICATE OF CONVENIENCE AND NECESSITY AND CANCELING ASSOCIATED TARIFF

Issue Date: January 2, 2007

Effective Date: January 12, 2007

On June 30, 2006,¹ White River Valley Water Company (“White River”) filed a verified application with the Missouri Public Service Commission requesting authority to sell its water system facilities and assets to the Public Water Supply District No. 2 of Taney County, Missouri (“PWSD”). On October 25, Staff filed its Recommendation Regarding Proposed Sale of Utility Assets, which recommended that White River’s application to sell its facilities and assets to PWSD be approved.

On November 16, after considering the verified application of White River along with the recommendation of Staff and accompanying verified memorandum, the Commission concluded that the application should be granted and issued an order authorizing White River to sell its water system facilities and assets to PWSD pursuant to the terms and conditions contained in the Facilities Purchase Agreement submitted to the Commission. The Commission's order also required White River to issue an appropriate pre-sale written notice to all customers in its service area informing them of the impending change in

ownership and operation. The order further stated that the Commission would entertain a motion to cancel the certificate of service authority currently held by White River with respect to its water system, along with the tariff on file pertaining to that system, once the notice was issued and the asset transfer was completed.

On December 26, White River moved the Commission to issue an order canceling White River's existing certificate of convenience and necessity and canceling the tariff associated with that certificate. White River's motion was accompanied by an affidavit indicating that the required pre-sale notice had been mailed to all customers on December 18.

Since all the prerequisites set forth in the Commission's order of November 16 have now been satisfied, the Commission will grant White River's motion and cancel both the certificate and the tariff associated with that certificate.

IT IS ORDERED THAT:

1. The certificate of convenience and necessity granted to White River Valley Water Company in Case No. WM-84-86 is hereby canceled, as is the tariff associated with that certificate (Tariff No. JW-2002-0081).
2. This order shall become effective on January 12, 2007.

3. This case may be closed on January 13, 2007.
