Mr. Woodruff:

KCP&L Greater Missouri Operations Company ("GMO") hereby submits a proposed rate schedule to adjust charges related to the approved Renewable Energy Standard Rate Adjustment Mechanism ("RESRAM"). GMO's RESRAM tariff requires the Company to make a filing each calendar year with each filing to become effective in December of each year. However, this semi-annual filing is necessary to remove the RESRAM Offset Adjustment ("ROA") in effect for the six-month period beginning December 1, 2016 through May 31, 2017 per File No. ET-2017-0097.

The current effective 3rd Revised Sheet No. 137.3 includes an ROA per kWh rate of (\$0.00032), resulting in a RESRAM per kWh rate of \$0.00059. This ROA is the result of a \$1.3 million disallowance per the Non-Unanimous Stipulation and Agreement in rate Case No. ER-2016-0156. Pursuant to 4 CSR 240-20.100(6)(11) of the Missouri Public Service Commission ("Commission") regulations, the ROA is designed to reconcile such disallowed costs within a six-month period immediately subsequent to any commission order regarding such disallowance. Accordingly, this ROA is effective for a six-month Disallowance Effective Period ("DEP"), or December 1, 2016 through May 31, 2017. Therefore, the Company is making this one-time filing to remove the ROA.

The proposed 4th Revised Sheet No. 137.3 has set the ROA per kWh rate to zero, resulting in a RESRAM rate applicable to customers' bills of \$0.00091 per kWh. The proposed rate schedule bears an issue date of March 31, 2017, and an effective date of June 1, 2017.

This proposed rate will result in an increase of approximately \$0.32 per month for residential customers using 1,000 kWh per month.

The next annual RESRAM rate adjustment will be filed September 30, 2017, with an effective date of December 1, 2017. The documentation containing information required by 4 CSR 240-20.100(6)(12) consisting of a RESRAM revenue reconciliation as well as workpapers supporting the proposed rate schedule will be updated and provided at that time.
