**ORDER APPROVING TARIFF  
AND REQUEST FOR EXPEDITED TREATMENT**

Issue Date: March 1, 2023

Effective Date: March 11, 2023

On February 24, 2023, Union Electric Company d/b/a Ameren Missouri filed tariff sheets for the Critical Needs Program, along with a motion for expedited treatment. Ameren Missouri's motion for expedited treatment asks the Commission to allow its tariff sheets to take effect on March 9, 2023, prior to the tariff sheets' proposed effective date of March 26, 2023. In support of its motion, Ameren Missouri states that good cause exists to make the Critical Needs Program tariff effective on March 9, 2023, because Ameren Missouri's Critical Needs Program and tariff reflect the collaborative efforts of the signatories to the Commission approved stipulation and agreement, and customers will benefit from the program. Ameren Missouri does not state any harm that will be avoided as required by Commission Rule 20 CSR 4240-2.080(14).

The Commission directed Staff to file an expedited recommendation, and set a deadline for any other responses to Ameren Missouri's tariff sheets. Staff recommends approval of the tariff sheets. The Office of the Public Counsel filed a response in support of Ameren Missouri's position.

The Commission has reviewed the tariff sheets and finds that they should be approved. The Commission has also reviewed the motion for expedited treatment and finds that good cause exists under Section 393.140(11), RSMo, to expedite the effective date of the tariff sheets. However, the Commission will not expedite the effective date of the tariff or this order to less than ten days. The Commission will approve Ameren Missouri's tariff sheets to become effective on March 11, 2023. In addition, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the tariff sheet.

**THE COMMISSION ORDERS THAT:**

1. Ameren Missouri's request for expedited treatment is granted as discussed in the body of this order.
2. The following tariff sheets filed by Ameren Missouri and assigned Tracking No. JE-2023-0165, are approved to become effective on March 11, 2023:
