Enclosed for filing with the Missouri Public Service Commission (Commission) on behalf of Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers), please find in electronic format certain water and sewer tariff sheets (list attached). These tariff sheets are being filed to adopt the existing water and sewer tariffs of Terre Du Lac Utilities Corporation (Terre Du Lac) pursuant to the Commission's *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* issued in Case No. WM-2020-0403.

In relevant part, Confluence Rivers was directed as follows - "Confluence shall submit an adoption notice before closing on the assets to adopt the existing Terre Du Lac tariffs." Confluence Rivers has not yet closed on the Terre Du Lac assets. Additionally, after discussion with the Commission Staff, Confluence Rivers is submitting an additional sheet for both water and sewer tariffs to address a previous error in the Terre Du Lac service area description.
