ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 6, 2010

Effective Date: August 16, 2010

On June 24, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting Syniverse Technologies, Inc. ("Syniverse") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2004-0187, the Commission granted Syniverse a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. MO No. 1, was also approved.

Staff states in its motion that Syniverse informed the Staff of the Commission that the company ceased operations and is no longer in business. The company further requested the Commission cancel their certificate of service authority and any accompanying tariffs. Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On July 14, 2010, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than July 26, 2010. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Syniverse Technologies, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Syniverse Technologies, Inc., in File Number XD-2010-0377, is canceled.
2. Syniverse Technologies, Inc.’s tariff, P.S.C. MO No. 1, is canceled.
3. This order shall become effective on August 16, 2010.

4. This case may be closed on August 17, 2010.
