ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 24, 2012

Effective Date: September 3, 2012

On August 10, 2012, the Staff of the Missouri Public Service Commission filed a motion requesting Ren-Tel Communications, Inc. ("Ren-Tel") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2003-0567, the Commission granted Ren-Tel a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 6, was also approved.

Staff states in its motion that Ren-Tel's parent company, Associated Telecommunications Management Service ("ATMS") contacted staff via letter stating Ren-Tel was no longer providing service in Missouri and requested the Commission cancel Ren-Tel's certificate of service authority. Staff noted that Ren-Tel is deficient in the filing of the Company's annual report for calendar year 2008 through 2011. Ren-Tel is also delinquent on its payment of its fiscal year 2012 assessment. Staff recommends that the Commission cancel the company's certificate of service

authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On August 13, 2012, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than August 23, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Ren-Tel Communications, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Ren-Tel Communications, Inc., in File Number XA-2003-0567, is canceled.
2. Ren-Tel Communications, Inc.'s tariff, P.S.C. Mo No. 6, is canceled.
3. This order shall become effective on September 3, 2012.

4. This case may be closed on September 4, 2012.
