On January 14, 2016, the fourth quarter QCA filing was submitted through EFIS on behalf of KCP&L Greater Missouri Operations Company – For St. Joseph, Missouri and Environs, providing the current Quarterly Cost Adjustment per the Stipulation and Agreement in Case No. HR-2009-0092.

Not included in this filing was the Lake Road Generating Station Coal Performance Adjustment made in October 2014 as a result of the unavailability of Boiler 5 to operate at full capacity. This document provides description and quantification of the Coal Performance Standard adjustment and was provided in the third quarter filing.
