ORDER APPROVING TARIFF

Issue Date: November 21, 2019

Effective Date: December 1, 2019

Evergy Missouri West, Inc., d/b/a Evergy Missouri West (f/k/a KCP&L Greater Missouri Operations Company) filed a revised tariff on September 30, 2019, to adjust its Renewable Energy Standard Rate Adjustment Mechanism (RESRAM) rates. The tariff revision carries a December 1, 2019 effective date.

The Commission's Staff filed a recommendation regarding the tariff on November 6, 2019. Staff explains that the tariff will increase the RESRAM \$0.05 per month for customers using 1,000 kWh per month. No party responded to Staff's Recommendation in the ten days' time allotted by Commission rule.¹

Staff recommends the Commission either approve the tariff, or allow it to go into effect by operation of law. The Commission will approve the tariff. The Commission further finds good cause for the order to take effect before thirty days' notice due to the fact that the tariff effective date of December 1, 2019 is less than thirty days from the date of Staff's recommendation filed on November 6, 2019.
