ORDER APPROVING COMPLIANCE TARIFF SHEETS

Issue Date: March 22, 2017

Effective Date: April 1, 2017

On March 8, 2017, the Commission approved a unanimous stipulation and agreement to resolve Ameren Missouri's request to increase the company's annual revenues from its provision of electric service. By approving that stipulation and agreement, the Commission authorized Ameren Missouri to file a tariff sufficient to recover revenues as determined in that stipulation and agreement. Ameren Missouri filed its compliance tariff on March 8.

Ameren Missouri's compliance tariff carries a 30-day effective date that would put the tariff in effect on April 7. However, Ameren Missouri filed a motion along with its tariff asking the Commission to expedite its consideration of the compliance tariff and to approve the tariff to go into effect on April 1.

Upon receiving Ameren Missouri's motion for expedited approval of its tariff, the Commission issued an order on March 9, directing its Staff to file a recommendation regarding Ameren Missouri's tariff by March 16. That order also directed any other party

wishing to file a recommendation regarding Ameren Missouri's tariff to do so no later than March 16.

On March 16, the Commission's Staff filed its recommendation regarding Ameren Missouri's compliance tariff and motion for expedited treatment. Staff concludes the tariff complies with the Commission's report and order, and recommends the Commission approve the compliance tariff to be effective on April 1. No other party filed a recommendation, and no party has filed a response to Staff's recommendation.

The Commission has reviewed the proposed tariff and Staff's recommendation. The Commission concludes the submitted compliance tariff is consistent with the approved stipulation and agreement. Expedited approval of the tariff is appropriate because the Commission has found that the rates resulting from the approved stipulation and agreement are just and reasonable. Thus, for good cause shown pursuant to Section 393.140(11), RSMo 2000, the Commission will approve Ameren Missouri's tariff to become effective for service rendered on and after April 1, 2017.

THE COMMISSION ORDERS THAT:

1. The proposed electric service tariff submitted under Tariff No. YE-2017-0173 by Union Electric Company, d/b/a Ameren Missouri, including a substitute tariff sheet filed on March 10, 2017, is approved effective on and after April 1, 2017. The specific tariff sheets approved are:
