# STAFF'S RESPONSE TO EMPIRE'S PROPOSED PROCEDURAL SCHEDULE

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff") and for its Response to Empire's Proposed Procedural states:

- 1. This case is the FOURTH in a series of cases spurred by Empire's August 18, 2006 Application for Variance, Case No. EE-2007-0030, and Application for Approval of Territorial Agreement, Case No. EO-2007-0029. In those cases, Empire requested expedited treatment for Commission consideration of a variance request which would allow Empire to bill what Ozark Electrical Cooperative would bill, as opposed to what Empire's lawful tariffs directed Empire to bill. While the case was pending, "a decision was made to proceed" by Empire and others, as Empire stated in paragraph 76 of its answer, as though a variance had already been granted.
- 2. The third case, which consisted of Empire's request to "unwind" its actions taken during the pendency of the first two cases and thereafter, was docketed as Case No. EO-2008-0043. As Empire states in paragraph 76 of its Answer:
  - ...[B] ecause that initial proposal was not accepted by the Commission, the parties then began the process of negotiations in an attempt to put everyone back into the positions they held prior to the proposal being made, while simultaneously

attempting to deal with the basic problem that had been initially raised by the City of multiple suppliers of electric service in the same area. These negotiations ultimately coalesced into another proposed territorial agreement that would allow Ozark Electric to exclusively serve The Lakes at Shuyler Ridge, along with Ozark Electric's agreement to buy out Empire's investment in the subdivision (which included all the facilities Empire had previously purchased from Ozark Electric). Because homes had been built in the subdivision by the developer and occupied by new customers in the intervening months while Commission approval was being sought, this new proposal also required the transfer of those customers who had come into existence while the previous cases had been pending. A request for approval of a new and different territorial agreement, the sale of certain Empire properties to Ozark Electric, and the transfer of customers (i.e., change of supplier) in the subdivision, was presented to the Commission for its approval in a joint application filed on August 15, 2007. This was approximately six months after the final disposition of the previous cases at the Commission. The Commission established a procedural schedule for that case on October 2, 2007, which called for hearings to commence on December 18, 2007. The Commission issued a report and order in Case No. EO-2008-0043 on March 4, 2008, effective March 14, 2008. That Report and Order was clarified in an order issued April 8, 2008, effective April 18, 2008. Those orders approved the proposed territorial agreement, the proposed transfer of customers, and the proposed transfer of facilities. It took eight months from the time that application was filed until there was a final resolution of that case.

- 3. Empire filed Compliance Tariffs on April 14, 2008. Those tariffs became effective for electric service rendered on or after May 14, 2008, in a May 2, 2008 Order. The case was closed May 15, 2008, and Staff filed its Complaint, docketed Case No. EC-2009-0078 on September 2, 2008.
- 4. As indicated in Appendix A to Staff's Complaint,<sup>1</sup> Empire began providing Permanent Service to facilities in The Lakes at Shuyler Ridge as early as December 21, 2006. February 28, 2007 is indicated as the date Empire began providing Permanent Service to 38 structures. Empire has an interest in delaying these proceedings is to allow it to argue the Statute of Limitations found at § 516.390 RSMo as a defense to a Commission-ordered suit for penalties in the circuit court.

All parties Surrebuttal: January 23, 2009

Issues List: January 28, 2009

Briefs: January 30, 2009

Hearing: February 4-5, 2009

6. For reference, please see attached, as Appendix A, the intervals Staff proposes for this case, as compared to Empire's last rate case, ER-2008-0043, and Empire's Requests for Variance and Territorial Agreements, which underlie the instant Complaint. Please see attached as Appendix B a redacted copy of Empire's Response to Staff Data Request 05 in Case No. EO-2008-0034, which indicates the dates Empire began providing service to structures in The Lakes at Shuyler Ridge in violation of its tariff.

WHEREFORE, the Staff moves the Commission to adopt the procedural schedule proposed by Staff.
