The purpose of this filing is to withdraw the current PSC MO No. 3 covering the Iowa Telecom
exchange of South Braddyville, MO and PSC MO No. 7 covering the Iowa Telecom Missouri
exchanges of Athens and South Seymour. The attached PSC MO No.1 General and Local Exchange
Tariff and PSC MO No. 2 Intrastate Interexchange Message Telecommunications Services Tariff are
complete replacement for these tariffs.

On January 4, 2000, GTE Midwest Incorporated (GTE) and Iowa Telecom filed a joint application seeking authority to transfer certain assets from GTE to Iowa Telecom in Case No. TM-2000-403 for three affected exchanges that extend into Missouri, Athens, South Braddyville, and South Seymour. The Missouri Public Service Commission approved the transfer by order issued May 25, 2000 effective June 6, 2000. On June 1, 2000 Iowa Telecom filed adoption notices by which it adopted, ratified and made its own the tariffs filed by GTE prior to June 30, 2000. The adoption notices indicated that they were to be effective on June 30, 2000. The Missouri Public Service Commission approved the tariffs filed on June 1, 2000 and assigned tariff number 200001207 to become effective on June 30, 2000.

Since the purchase of the GTE properties, Iowa Telecom has made numerous changes to its products and services tariffs, including the addition of new service offerings to its Iowa customers. The GTE Missouri tariffs adopted on June 1, 2000 bear an effective date in 1991 and have not been updated since they were adopted. In a recent billing and tariff audit of the Missouri accounts, a billing error was discovered. During the conversion to a new billing system in September 2004, some of the rates for the Missouri customers were inadvertently increased to the current Iowa level and subsequently changed again with a rate change that occurred for Iowa customers effective January 17, 2005. Local rates for Iowa business and residence customers were also increased on January 1, 2006 and February 1, 2006, respectively. This filing is intended to update and align the tariffs for the Missouri customers with the level of the rates and services provided to the Iowa customers.

Iowa Telecom is notifying the affected customers of the changes to their accounts based on their current level of billing. In addition, the notification will also advise customers of refunds for any overcharges that will appear on their April 1, 2006 billing statements. Attachment 1 is a copy of the notification that will be sent to the customers. Attachment 2 is a summary of the billing changes that will affect the customers.

In an effort to align the service rates Iowa Telecom charges customers in Missouri and Iowa, we recently completed a billing and tariff audit. New service rates will become effective April 1, 2006.
