## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: July 10, 2012 Effective Date: July 20, 2012

On June 28, 2012, the Staff of the Missouri Public Service Commission filed a motion requesting Capital International Communications, LLC ("Capital International") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication services in the State of Missouri be cancelled.

In File Number XA-2004-0250, the Commission granted Capital International a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that Capital International filed its 2011 Statement of Revenue which indicated that the company no longer wished to retain its operating certificate. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications services.

On June 29, 2012, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than July 9, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Capital International's request and Staff's motion, the Commission finds that the certificate of service authority granted to Capital International Communications, LLC, shall be canceled. Although Staff did not request the cancellation of the accompanying tariff, Capital International cannot provide service without a certificate. Therefore Commission will also cancel Capital International's tariff, P.S.C. Mo No. 1.

## IT IS ORDERED THAT:

- 1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Capital International Communications, LLC, in File Number XA-2004-0250, is canceled.
- 2. Capital International Communications, LLC's tariff, P.S.C. Mo No. 1, is canceled.
  - 3. This order shall become effective on July 20, 2012.

4. This case may be closed on July 21, 2012.
