ORDER SUSPENDING TARIFF SHEET AND GRANTING EXTENSION OF TIME

On May 16, 2022, Union Electric Company d/b/a Ameren Missouri filed a revised tariff sheet, Tracking No. JE-2022-0259, designed to update its Solar Generation Charge and Total Solar Block Charge in the Community Solar Pilot Program to reflect the recent completion of the Montgomery County Energy Center. The revised tariff sheet bears an effective date of June 16, 2022.

The Commission set a time for responses to the revised tariff sheet and directed its Staff to file a recommendation. On May 27, 2022, the Staff of the Commission filed a motion requesting up to 30 additional days to file its recommendation and a 15-day suspension of the revised tariff sheet. Staff explained that it had received in-service information from Ameren Missouri on the day prior to filing its motion and needed the extension to review that information. On June 3, 2022, Ameren Missouri filed a response stating that it did not object to Staff's motion. No other responses to the motion were received.

The Commission has considered the unopposed motion and finds it reasonable to grant Staff an extension of time and to suspend the tariff sheet. However, given the timeline requested by Staff, the Commission will not have time to allow responses to Staff's recommendation or to act on its recommendation if the tariff is only suspended for 15 days. Therefore, the Commission will extend the filing date of Staff's recommendation for 28 days¹ and suspend the tariff sheet for 30 days. The Commission will also shorten the time for responses to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. No later than June 23, 2022, Staff shall file a recommendation regarding the revised tariff sheet.

2. Any responses to Staff's recommendation shall be filed no later than June 30, 2022.

3. The tariff sheet filed by Ameren Missouri on May 16, 2022, Tracking No. YE-2022-0259, is suspended until July 16, 2022.

4. This order shall be effective when issued.
