Atmos Energy Corporation herewith submits for filing the 3rd Revised Sheet No. 44 for all areas of Missouri which replaces the 2nd Revised Sheet No. 44. Also enclosed with 3rd Revised Sheet No. 44 are the supplementary sheets setting forth the detailed calculations of each revised PGA.

This filing reflects an increase in rates for all the areas of Missouri. As a result of this filing a typical residential customer in the West Area (Old Butler) will experience an increase of approximately 55%; in the West Area (Old Greeley) an increase of approximately 38%, in the Southeastern Area (Old SEMO) an increase of approximately 47%; in the Southeastern Area (Old Neelyville) an increase of approximately 52%, in the Kirksville Area an increase of approximately 48%, and in the Northeastern Area approximately an increase of 47% during this summer season.

Your review and approval of these sheets to become effective June 1, 2008 are respectfully requested.
