
I received the attached document via FedEx delivery from Thomas A. Beck, President – Continental Cement, regarding the above referenced case.

Dear Honorable Chairman and Commissioners:

I am writing today to notify you that Continental Cement Company opposes the February 12, 2014, rate case filing made with the Missouri Public Service Commission (PSC) by Noranda Aluminum - New Madrid, MO. This rate case will adversely impact Continental Cement and most Missouri residents, as well.

While smelters do require a great deal of electricity, Noranda has already negotiated the lowest rate of any Ameren customer, paying less for electricity that it costs to produce it. Producing cement is also an energy intensive business. As one of Ameren's top-20 customers, we do not feel that Noranda is entitled to any further reduction in their rates . . . especially at our expense.

The claim filed by Noranda seeks to further reduce their rate by another 25%. This reduction would shift additional costs to other Ameren customers such as Continental Cement . . . costing us an estimated \$1Million+ over the next 10 years. We hope that you do not allow this to happen.
