## STATUS REPORT

**COMES NOW the** Staff of the Missouri Public Service Commission, by and through the undersigned counsel, on behalf of itself, Ms. Caves and Empire, collectively ("the parties") and files this Status Report with the Missouri Public Service Commission stating the following:

- 1. On July 31, 2014,<sup>1</sup> Regulatory Law Judge Burton directed Staff to file a status report by August 8 stating whether Ms. Caves wants to proceed with mediation or towards an evidentiary hearing, and if a hearing, proposed dates and location for the hearing.
- 2. On July 31, Ms. Caves and Empire engaged in settlement discussions on the issues raised in her Complaint. Since the parties are still working toward resolution of the issues, three alternative dates for a hearing in Joplin, Missouri, were determined that would work for all the parties. They are September 25, 26, and 29.
- 3. Staff has discussed this report with the Office of the Public Counsel, which has authorized the undersigned to state it does not object to the proposed hearing dates.
