## ORDER GRANTING MOTION TO STAY FORMAL COMPLAINT

On July 31, 2018, William L. Gehrs, Jr. filed a complaint against The Empire District Electric Company. On June 5, 2018, Gehrs requested additional time to file direct testimony and the Commission suspended the procedural schedule until August 26, 2018. On July 18, 2018, Gehrs filed a motion to stay the complaint until the disposition of a lawsuit.

On November 1, 2018, Gehrs filed his *Reply to Order Setting Procedural Conference for November 5, 2018 at 10:00 a.m.* requesting that the complaint be stayed until January 18, 2019. The Empire District Electric Company did not oppose Gehrs's request. The Commission will grant the motion to stay the complaint additionally until February 10, 2019.
