ORDER DIRECTING FILING AND ORDERS FOR A SMALL COMPLAINT

The Commission is granting the *Motion to Request Status Change* (“motion”).¹ The motion asks the Commission to apply the Commission’s small formal complaint procedures.² The Commission took up the motion at the May 2, 2018 conference³ and no party objected. The Commission will grant the motion and apply small formal complaint procedures to the remainder of this proceeding.

Also at the conference, the Commission instructed the Commission’s staff to coordinate and file a proposed procedural schedule, and the Commission will set a time for that filing.

The Commission’s small formal complaint procedures include dispensing with pre-filed written testimony,⁴ and the Commission will dispense with pre-filed testimony
