**PROPOSED PROCEDURAL SCHEDULE**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through the undersigned counsel, and hereby files its *Proposed Procedural Schedule*, in response to the Commission's May 2, 2018 *Order Directing Filing and Orders for a Small Complaint* ("May 2 Order"):

1. On September 28, 2017, Complainant filed her *Complaint* in this docket.
2. On January 23, 2018, Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri") filed its *Answer, Affirmative Defenses and Motion to Dismiss*.
3. On February 13, 2018, Staff filed its *Report*.
4. On February 28, 2018, Ameren Missouri filed its *Response to Staff Report*.
5. On March 19, 2018, Complainant filed both a *Notice Regarding Power Outage* and her *Response to Staff Report and Ameren's Response to Staff Report*.
6. On May 2, 2018, a prehearing conference was held to provide the parties a better avenue for discussion and agreement on procedural requirements, a procedural schedule, and a date for an evidentiary hearing.

7. On May 2, 2018, the Commission ordered Staff to coordinate and file a proposed procedural schedule no later than May 11, 2018.

8. After discussing with the parties to the Complaint, Staff recommends the Commission adopt the following procedural schedule for this case:

<b><u>Item</u></b>	<b><u>Date</u></b>
Last day to request discovery	June 8, 2018
Evidentiary Hearing	June 19, 2018

9. The parties also discussed discovery and agreed that the time to respond to data requests should be shortened to 10 calendar days, with 5 calendar days to either object or notify the requesting party that additional time is needed to respond.

**WHEREFORE**, Staff respectfully submits this proposed procedural schedule in compliance with the Commission's May 2, 2018 order.
