ORDER DIRECTING COMPLAINANT TO SHOW CAUSE WHY COMPLAINT SHOULD NOT BE DISMISSED

Issue Date: September 21, 2018

Claude Scott filed a complaint against Union Electric Company, d/b/a Ameren Missouri ("Ameren Missouri") on June 11, 2018. A prehearing conference was scheduled for September 20, 2018, beginning at 10:00 a.m. Ameren Missouri and the Commission's Staff were present at the prehearing conference. Mr. Scott failed to appear in person or by telephone, and did not contact the Commission prior to the prehearing conference to request a continuance.

Commission Rule 4 CSR 240-2.090(5) provides that "[f]ailure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of ...the party's complaint...unless good cause for the failure to appear is shown". The Commission will not dismiss the complaint without giving Mr. Scott an opportunity to explain why he did not attend the prehearing conference. Therefore, Mr. Scott shall file a pleading showing cause why his complaint should not be dismissed.

THE COMMISSION ORDERS THAT:

1. Claude Scott shall file a pleading no later than October 1, 2018, showing cause why his complaint against Union Electric Company, d/b/a Ameren Missouri should not be dismissed.
2. This order shall be effective when issued.
