PROPOSED PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission (Staff), and for this *Proposed Procedural Schedule*, states in support:

1. On June 15, 2018, Ms. Stella Lucy (“Complainant”) filed a complaint with the Missouri Public Service Commission (“Commission”). On the same day, the Commission issued its Order Giving Notice of Contested Case and Directing Answer ordering Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri” or “Respondent”) to satisfy the complaint or file a response by July 16, 2018 and directing the Staff to investigate and file a report by July 31, 2018.
2. Ameren Missouri filed its *Answer, Affirmative Defenses and Motion to Dismiss Claim for Damages* on July 16, 2018.
3. Staff filed its *Staff Investigation Report* on July 31, 2018.
4. On August 14, 2018, the Commission issued its *Order Setting Pre-Hearing Conference*, requiring that a procedural conference be held September 13, 2018.
5. Staff, Complainant, and Respondent, agreed to waive the discovery process. The Parties will leave it to the Commissions’ discretion whether it desires closing arguments and/or briefs or none of these. If the Commission desires a different

procedural schedule than the one set out herein, please indicate so in the order setting procedural schedule. The Parties also agree on the following procedural schedule for this case:
