**ORDER SETTING PROCEDURAL SCHEDULE**

Issue Date: September 9, 2005

Effective Date: September 9, 2005

On September 8, 2005, the Staff of the Commission filed a Motion to Establish Procedural Schedule. The motion omitted prefiled testimony.

The Commission has reviewed the motion and agrees that there is no need for prefiled testimony in this case. The Commission will waive the portion of its evidence rule<sup>1</sup> that requires prefiled testimony and will direct that all testimony be live at the hearing. Therefore, the Commission will set the hearing as directed below.

In addition, the following procedures shall apply:

(A) The hearing will begin with brief opening statements.

(B) Each of the parties shall file a list of its witnesses to appear and the order in which they shall be called.

(C) The Commission's general policy provides for the filing of the transcript within ten days after the hearing. If any party seeks to expedite the filing of the transcript further, such request shall be tendered in writing to the Presiding Judge at least five days prior to the date of the hearing.

(D) All parties are required to bring an adequate number of copies of exhibits that they intend to offer into evidence at the hearing. If an exhibit has been previously filed, and served on the other parties, only a copy of the exhibit for the court reporter is necessary. If an exhibit has not been previously filed, the party offering it shall bring one copy for the court reporter, copies for the five Commissioners, the Presiding Judge, and all counsel.

**IT IS THEREFORE ORDERED:**

1. That the Motion to Establish Procedural Schedule is granted.
2. That the procedural schedule is ordered as follows:
