On November 17, 2022, the Commission issued its *Amended Report and Order* regarding Evergy Missouri West's request for a financing order that authorizes the issuance of securitized utility tariff bonds. That *Amended Report and Order* became effective on November 27, 2022. The Office of the Public Counsel filed a timely motion for clarification and application for rehearing.

Section 386.500.1, RSMo, indicates the Commission shall grant an application for rehearing if "in its judgment sufficient reason therefor be made to appear." In the judgment of the Commission, the applicants have not shown sufficient reason to rehear the amended report and order. The Commission also does not find that its *Amended Report and Order* requires clarification as requested by the Office of the Public Counsel. Therefore, the Commission will deny the Office of the Public Counsel's *Second Motion for Clarification and Second Application for Rehearing*.

1. The Office of the Public Counsel's Second Motion for Clarification and

Second Application for Rehearing is denied.
