ORDER DIRECTING RESPONSE

The Commission stated its positions on the various issues presented by the parties for resolution at the September 22, 2022, agenda. Those decisions have not yet been finalized in an order, but the Commission will require the assistance of the parties in determining the exact dollar amounts that should be included in the financing order resulting from those decisions. To that end, the Commission will direct Staff to work with the other parties to file scenarios calculating the numbers for the following costs using the following positions:

1. Total amount to be securitized for Winter Storm Uri qualified extraordinary costs.
2. Total Amount of Winter Storm Uri qualified extraordinary costs, assuming application of the 5 percent adjustment proposed by Staff, and the agreement by the parties to recover the non-fuel operation and maintenance costs through the rate case, with no other disallowances or adjustments. Carrying costs to be calculated using the long-term rate of 5.06 percent.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file the above described scenarios no later than September 30, 2022.
2. If any party disagrees with the Staff's scenarios, they may file separate scenarios no later than September 30, 2022.
3. This order shall be effective when issued.
