Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy) attached a draft financing order to the direct testimony of Evergy witness Steffen Lunde (Schedule SL-2), which shows how Evergy believes its positions would be reflected in a final financing order. Accordingly, the Commission will direct its Staff to file a draft financing order with its initial brief on August 31, 2022. Other parties are will not be ordered to file a draft financing order, but are welcome to submit either a draft financing order or suggestions for a financing order with their initial briefs.

The Commission is also providing notice that it intends to ask witnesses questions about Evergy's draft financing order at the evidentiary hearing.

THE COMMISSION ORDERS THAT:

1. Staff shall submit a draft financing order with its initial brief.
2. Other parties may submit a draft financing order or suggestions for a financing order with their initial briefs.

3. This order is effective when issued.
