**STATUS REPORT AND MOTION TO CLOSE CASE**

COMES NOW Citizens Electric Corporation ("Citizens") by and through its attorneys, Andereck, Evans, Milne, Peace & Johnson, by Victor S. Scott and Lisa Chase, and states to the Commission that there has been no change in the status of the above matter since Citizens report to the Commission dated June 13, 2003. For further information Citizens states that this case was for \$6,983,000 in financing. In August 1999, Citizens locked in long-term \$2,920,000. In June 2000, Citizens locked in long-term \$1,961,000. In September 2000, Citizens locked in long-term \$2,102,000. These three draws downs equate to the entire \$6,983,000 loan amount. Therefore Citizens requests an order closing this case.

Citizens Electric Corporation further requests that the Commission close this matter as the Commission no longer has jurisdiction over the rates, financing, account or management of Citizens since the passage of Senate Bill No. 255, which amends Section 393.110.2

WHEREFORE, Citizens Electric Corporation respectfully requests an Order from the Commission closing this case, as one all of the loan funds have been drawn down and two the Commission now lacks jurisdiction over this matter.
