**MOTION FOR EXTENSION**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and for its *Motion for Extension* states:

1. On April 22, 2019, Pulsar360, Inc. (Company) filed a *Notification of Transaction* between itself and a newly formed corporation, Pulsar360 Corp. Pursuant to the transaction, all of the assets of Pulsar360, Inc. would be transferred to Pulsar360 Corp.

2. Pursuant to 4 CSR 240-28.011(2) a company with a certificate or registration that changes its name shall provide advance notice to the Commission of the name change along with a statement filed in the Commission's electronic filing and information system (EFIS) containing the new name of the company and the date the new name takes effect; documentation that the new name is registered with the Missouri Secretary of State; and a statement that the company has reviewed and/or updated its contact information in EFIS.

3. To date the Company has not filed notice of the date the new name will take effect, documentation that the new name is registered with the Missouri Secretary of State or a statement that the Company has reviewed and/or updated its contact information in EFIS. Without this information Staff cannot recommend that the Commission take notice of the name change. Staff prays that the Commission order

Pulsar360, Inc. and Pulsar360 Corp. to file the necessary declarations and documentation and grant Staff an additional 30 days in which to file its recommendation.

**WHEREFORE**, Staff respectfully asks that the Commission order 1) Pulsar360, Inc. and Pulsar360 Corp. to file notice of the date the Company's new name will take effect, documentation that the new name is registered with the Missouri Secretary of State and a statement that the Company has reviewed and/or updated its contact information in EFIS; 2) permit Staff to file its recommendation no later than June 7, 2019; and 3) grant such further and other relief as is just in the circumstances.
